Cancellation of all memberships require a 3 month notice period or will incur a cancellation fee equivalent to 3 months membership fees. Members remain responsible for all fees and charges applicable during this notice period, including any applicable cart or usage fees. Complimentary member guest passes are not valid during the notice period.

Management reserves the right to suspend or terminate membership at any time. The club reserves the right to update these terms at any time, with reasonable notice provided to members.
